

Superintendent Danny Hayes recommended the board approve the Surplus Vehicles and Buses to be purged from the inventory Thomas Barton moved approval and Bill Worley seconded. The board approved 4-0.

### Bus Purchase

Mike Ewton, director of the Transportation Department, recommended the purchase of four new school buses utilizing funds provided by the State of Georgia bond sales. Reimbursement from the state will be in the amount of \$76,219.50 per bus. In order to purchase buses that meet our current minimum specifications, the purchase price will be \$88, 507 each for three 72 passenger route buses and \$93,647 for the 48 passenger special needs bus. We intend to purchase Thomas Built buses from Peach State Freightliner. Thomas Built buses were less expensive than the other two Georgia bus companies on the state contract. The total cost of all the buses will be \$359,168.00 with \$304,878 00 of that amount to be reimbursed by the State of Georgia. The remaining balance of \$54,290.00 will be paid by local funds. These funds have been budgeted for this purpose.

Superintendent Danny Hayes recommended the board approve the purchase of the four school buses. Louis Fordham moved approval and Rodney Lock seconded. The board approved 4-0.

She thanked the board and Mr. Hayes for this wonderful opportunity to make such a difference in a child's life. Mr Hayes thanked her for her hard work

Tami Dodd gave the board a handout on facts about Antioch. A copy is included in the back up minutes Tami told the board that our student population is 68% Hispanic, 31% Caucasian, and 1% Other. Even with our high poverty rate and language barriers our students still learn and make progress in the classroom They know that there is still a lot of work to be done. To help increase Science scores they hired a Science teacher with Title I money to supplement their Science curriculum and increase student engagement with hands-on learning. Our Literacy focus will help students in all academic subjects.

# System Reports

# Teaching and Learning

Caroline Woodason, Coordinator for Teaching and Learning, told the board that the training for the new Common Core standard is still going on. With the increased rigor of the Common Core Standards we want to make sure that our teachers are ready. We did a Survey Monkey to assess the needs and support of what the teachers still needed. A lot they have asked for is more collaboration between teachers to help design new lessons that are aligned with the new standards.

Caroline Woodason told the board that another change for WCS will be the PARCC (Partnership for Assessment of Readiness for College and Careers) Online Multiple Choice Test. This is a consortium of 23 states

- Build a pathway to college and career readiness for students
- Creates high-quality assessments that measure the full range of the Common Core State Standards
- Supports educators in the classroom
- Makes better use of technology in assessments
- Advances accountability at all levels

This will be an online test. At this time she played an example of a question about Amelia Earhart. It can be administered up to four times a year but the state of Georgia still does not know how this will be funded. She said that we will be administering the CRCT test this year but with PARCC questions.

Another change for next year will be teacher evaluation. She told the board that there are a lot of changes taking place in the state of Georgia.

Caroline gave the board a handout on the training they will attend on Thursday, November 29, 2012 at the PAGE office in Atlanta. This is a part of the backup minutes She told them this would be facilitated by George Thompson with the Schlechty Center.

Judy Gilreath, assistant superintendent for Student Services, presented the following information for Dr. Audrey Williams, assistant superintendent for Teaching and Learning
