Hearing of Individuals

Debby Peppers wanted to talk to the board about Positive Behavioral Interventions and Support (PBIS). She said that PBIS is an evidence-based, data driven framework proven to reduce disciplinary incidents, increase a school's sense of safety and support improved academic outcomes. She said that more than 19,000 U.S. schools are implementing PBIS. She said that Murray County has implemented PBIS district-wide since 2008-2009. She said that the discipline outcomes realized over time have been significant.

- Discipline events have reduced in Murray County Schools by 45%
- Discipline actions (ISS, OSS, Detention) assigned by administrators reduced by 37%
- The graduation rate has improved by 14%

Debby Peppers stated that the second issue is our tribunal staff. We use our own staff for a tribunal. She said that we need to look at the process and bring in an independent group to do our tribunals. She thanked the board for opportunity to speak and for their time.

Whitfield County Schools Revised 2014-2015 Calendar

Karey Williams, Assistant Superintendent, requested to amend the 2014-2015 School Calendar. She said that during the months of February and March Whitfield County Schools was closed for 5 days due to inclement weather. One day was made up on March 13th because this day was already built into the calendar as an inclement weather day. She said that we are requesting that the 2014-2015 Calendar be amended to reflect 172 instructional days instead of the original 176 days. There are enough extra minutes in each school day to still meet the "180 Day Equivalent" standard required by the state. Louis Fordham said that a recommendation had been made to Amend the 2014-2015 School Calendar. Thomas Barton moved approval and Tony Stanley seconded. The board approved 5-0.

2015-2016 School Calendar

Karey Williams, Assistant Superintendent, recommended that the board adopt the 2015-2016 School Calendar. She said that the calendar committee has worked very hard and given a lot of time. The committee recommends adding back two instructional days for a total of 178 days. Teachers have six professional/work days. Louis Fordham said that a recommendation had been made to adopt the 2015-2016 School Calendar. Louis Fordham moved approval and Bill Worley seconded. The board approved 5-0.

Assessment and Accountability

House Bill 91: Graduation Test Waivers - Dr. Audrey Williams

Dr. Audrey Williams, Chief Officer for Assessment and Accountability, told the board that the 2015 authorization of HB 91 created a new state law which provides that students shall no longer be required to earn a passing score on any graduation tests to earn a high school diploma. Students no longer enrolled can petition the local board of education for a diploma. A copy of the Diploma Request Form is in this board packet.

Operations

Ashton Staffing Contract Renewal

Mike Ewton, Chief Officer for Operations, recommended that the board approve the renewal contract with Ashton Staffing. This contract is for 31% food service, landscape and maintenance and 26% sub teachers and after school care. Angie Brown, School Nutrition Director, said that Ashton had met all requirements of the bid and we have not had any issues with this vendor in the past. Louis Fordham said that there has been a recommendation to approve the Renewal Contract with Ashton Staffing. Rodney Lock moved approval and Thomas Barton seconded. The board approved 5-0.

Wanda Phillips, Chief Officer for Support Services, presented the first reading of the Student Discipline Code for WCS. Wanda told the board that there were two laws that have been passed but can't put in book until state sends the correct wording. This has to do with 1B Hazardous Objects and 2H Cyber Bullying. She informed the board of the following changes. They are in bold print:

- Section B: Inappropriate Dress: Pajamas or **similar styles.** Hair of any **style that is** disruptive to the learning environment.
- Section A: Acceptable Standards for Proper Attire:
 - Shirts/Blouses: Fit
 - Sized appropriately, fitted modestly, (no cleavage showing), sleeveless with material extending from collarbone to end of shoulder bone
 - Skirts/Dresses/ Jumpers: Fit
 - Sized appropriately, fitted modestly, (no cleavage showing), sleeveless with material extending from collarbone to end of shoulder bone
 - Pants/Slacks/Shorts: Styles
 - o (no overalls, pajama pants, or similar styles)

Dr. Gilreath recommended that the board approve the first reading of the 2015-2016 Student Discipline Code of Conduct. Bill Worley moved approval and Tony Stanley seconded. The board approved 5-0.

First Reading of Whitfield County Schools Student Dress Code: Grades 6-12
