Project SEARCH - Whitfield County Schools Wins 100% Employment Award

The board presented a certificate of congratulations to Project SEARCH for receiving the Outcome Award for 100% Employment for 2013-2014. Kathy Reed, ESS Coordinator, received the certificate. She introduced Karen Hutchinson, Project SEARCH Instructor and Laura Beavers with Crossplains, community partner. She said that they have worked very hard with the interns.

Duke Talent Identification Program (TIP) 2014-2015

Shanda Hickman, Gifted Coordinator for Whitfield County School, shared some information about Duke TIP and how the students are chosen to participate. She said that the Duke University Talent Identification Program identifies gifted students and helps them reach their highest potential. Shanda said the 7th Grade Talent Search offers qualifying seventh grade students the opportunity to take the SAT or ACT alongside high school students. 7th grade students with strong intellectual abilities are invited to participate if they achieve a qualifying score at or above the 95th percentile on a recent grade-level test. Depending on their score they can then participate in the summer studies that are offered. Students who are among the top 5 percent academically can attend The Duke TIP Academy for Summer Studies. She said that we had seven students that qualified. Shanda said that students who qualify for the Center for Summer Studies are the highest-scoring students in Duke Tip's 7th Grade Talent Search. She said that we had two students that qualified. Shanda said that she is very proud of each of these students.

ESOL Program Facts

Strategic Plan: Goal 1

Sheltered Instruction Observation Protocol

• At the end of the year, we will have 14 trained cohorts of teachers. (423 teachers, plus 31 SIOP coaches). The focus is on best instructional practices and effective strategies to accelerate learning.

Advanced Manufacturing Pathway Northwest Georgia College and Career Academy

Karey told the board that this is a great program. The Advanced Manufacturing (AM) Pathway is a high-school level program of study that is designed to prepare and equip students with essential academic and employment skills and abilities for jobs and careers in manufacturing. It combines a four (4) year academic track and a two (2) year apprenticeship for the purpose of providing students with both foundational and applied learning and instruction in Advanced Manufacturing principles and systems and real-world on-the-job experience. Students completing the Advanced Manufacturing Pathway will be prepared to continue their education with post-secondary options or enter the manufacturing industry. Karey said that local business and the community have put a lot into this. She said that students will be required to attend school two days a week.

Assessment and Accountability

House Bill 91: Graduation Test Waivers

Dr. Audrey Williams, Assistant Superintendent for Assessment and Accountability, gave an update on HB: 91. This is the bill that created a new state law which provides that students shall no longer be required to earn a passing score on any graduation tests to earn a high school diploma. She said that we have given out 347 diplomas since April of 2015.

Strategic Waivers School System/Investing in Educational Excellence (IE2)

Dr. Audrey Williams, Assistant Superintendent for Assessment and Accountability, presented the following information on the Strategic Waivers School System/Investing in Educational Excellence Partnership:

State Law Requirement

No later than June 30, 2015, each local school system had to notify GaDOE that it will operate as an:

- 1. Investing in Educational Excellence School System (IE2) (Strategic Waiver System) or
- 2. Charter System or
- 3. Status Quo School System

Whitfield County School System's Decision

On April 10, 2015, the Whitfield County Superintendent drafted a letter of intent for the district to operate as an IE2 – Strategic Waiver System. On April 13, 2015, the Whitfield County Board of Education voted and signed a resolution authorizing the letter of intent for the Investing in Educational Excellence Model with the Georgia Board of Education.

What is Strategic Waivers School System?

When HB 502 went into effect on July 1, 2015, districts that chose the Investing in Educational Excellence (IE2) are now known as **Strategic Waivers School Systems (SWSS/IE2).**

Districts enter into a performance contract with the State Board of Education (SBOE) in order to receive freedom from specific state laws and rules in return for increased academic accountability.

Performance contracts have two main parts:

- 1. Academic and other performance targets to which the school system is committed.
- **2. Waivers** granted by the SBOE to the school system.

Contract Terms

Initial contract is for seven years with five years of accountability using baseline assessment data from the 2015-2016 school year. By law, the Governor's Office of Student Achievement (GOSA) must monitor the district's progress in meeting its contracted performance goals. Schools meeting the equivalent of three years of targeted improvement by the end of the contract will be deemed as meeting the accountability requirements of the contract.

An application must be submitted which contains the partnership contract, the District Strategic Plan, flexibility requested, accountability with targets, consequences including sanctions and interventions for non-performing schools, and school plans consisting of targets, grade levels, demographics, and the most current statewide assessment data.

Strategic Waivers School System/IE2 - Waivers

State Law requires that the goal of each waiver shall improve student performance.

Must include one of these:

- Class Size requirement
- Expenditure Controls/Categorical allotment requirements
- Certification requirements
- Salary Schedule requirements
- * Cannot ask for waivers from Federal Rules

District Support

The district will provide support throughout the contract for each school based on the needs of that school.

Timeline and Next Steps

- Submit Letter of Intent to GaDOE. $\sqrt{}$
- Submit draft application to GaDOE.
- District holds Public Hearing for Strategic Waiver's School System/IE2. √
- District finalizes application and submits for local approval.
- District submits final application to GaDOE.
- GaDOE and GOSA sign off on final documents submitted.
- GaDOE Legal Services Division finalizes our contract.
- SBOE Flexibility Committee recommends approval or denial of the contract.
- Contract is signed.
- GOSA will provide school targets by January 2017.

Audrey told the board that our application should be ready to go by December.
